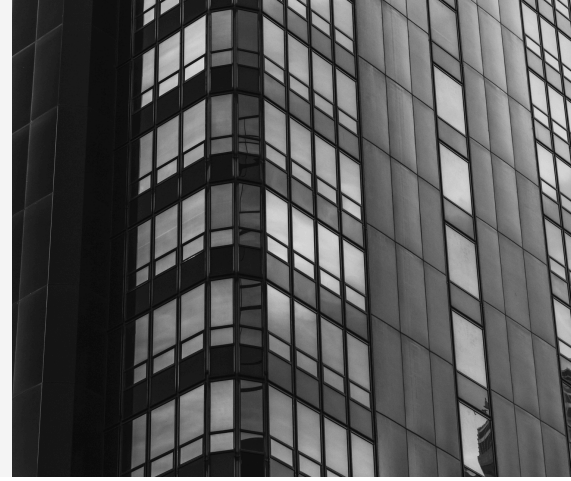

TECHNOLOGY OVERVIEW

BLOCKCHAIN ARCHITECTURE

Movo Smart Chain adopts a modern blockchain architecture with the **Proof of Staked Authority (PoSA)** consensus mechanism. This combines the advantages of Proof of Stake and Authority, offering:

- **High transaction speeds:** Capable of processing up to **50,000 TPS (Transactions Per Second)**, surpassing **BSC (150 TPS)** and **Solana (65,000 TPS)**.
- **Low transaction costs:** Average gas fees are under **\$0.0001**, making it user-friendly.
- **High scalability:** Supports millions of daily transactions without compromising performance.
